

# TERMS OF SERVICE AGREEMENT

## ACCEPTANCE OF TERMS

The following Terms of Service Agreement (the "TOS") is a legally binding agreement that shall govern the relationship with our users and others which may interact or interface with Whosoever Will Outreach Ministries, also known as WWOM, located at PO Box 363, Ridgeland, South Carolina 29936 and our subsidiaries and affiliates, in association with the use of the WWOM website, which includes Livingstrongtv.com, (the "Site") and its Services, which shall be defined below.

## DESCRIPTION OF WEBSITE SERVICES OFFERED

The Site is streaming faith base website which has the following description:

The purpose of Living Strong Television Network (LSTN) is to establish an online global internet television network that displays new independent programming that is faith based and family oriented; while including other user valued content. We will target the faith based, urban, international and multilingual communities. The network has three content based websites in which the media player is embedded; for the purpose of generating revenues through advertising. These websites will develop a community of users by offering value-based content free of charge. The media players broadcast the same content on every website which includes shows as well as a late night streaming music broadcast. Although the player will broadcast the same content, each website will display other content which vary in the following areas; discussion boards, prayer request, articles, photos, illustrations, sport articles, how-to articles, and other yet to be determined content.

Any and all visitors to our site, despite whether they are registered or not, shall be deemed as "users" of the herein contained Services provided for the purpose of this TOS. Once an individual register's for our Services, through the process of creating an account, the user shall then be considered a "member."

The user and/or member acknowledges and agrees that the Services provided and made available through our website and applications, which may include some mobile applications and that those applications may be made available on various social media networking sites and numerous other platforms and downloadable programs, are the sole property of Whosoever Will Outreach Ministries. At its discretion, Whosoever Will Outreach Ministries may offer additional website Services and/or products, or update, modify or revise any current content and Services, and this Agreement shall apply to any and all additional Services and/or products and any and all updated, modified or revised Services unless otherwise stipulated. Whosoever Will Outreach Ministries does hereby reserve the right to cancel and cease offering any of the aforementioned Services and/or products. You, as the end user and/or member, acknowledge, accept and agree that Whosoever Will Outreach Ministries shall not be held liable for any such updates, modifications, revisions, suspensions or discontinuance of any of our Services and/or products.
